condemned by the superintendent or head of the institution owning the same, together with the head of the department in which the said machinery or property has been used, and the superintendent of buildings and grounds of said institution or the person who has supervision of said buildings and grounds by whatever name he may be designated, and by the state business manager. Such condemnation shall be in writing and filed in the office of the state business manager.

SEC. 3. That the money received from the sale of any of said property, as provided for in section 1 of this act shall be deposited with the state treasurer to the credit of the fee fund of the particular state institution from which such property or supplies are sold, and that the auditor of the state is authorized to draw warrants upon the treasurer of the state against such funds upon vouchers duly approved by the business manager of the state board of administration or of the board of regents for the maintenance of the particular state institution to which such property or supplies belonged.

SEC. 4. That chapter 253 of the Laws of Kansas for 1925 (being sections 76-116a and 76-116b of the 1930 Supplement to the Revised Statutes of Kansas for 1923), is hereby repealed.

SEC. 5. This act shall take effect and be in force from and after its publication in the statute book.

CHAPTER 296.

CHANGING THE NAME OF THE KANSAS STATE AGRICULTURAL COLLEGE TO THE KANSAS STATE COLLEGE OF AGRICULTURE AND APPLIED SCIENCE.

House Bill No. 496.

AN ACT changing the name of the Kansas state agricultural college to that of the Kansas state college of agriculture and applied science, and directing the state board of regents to maintain courses therein, amending section 76-401 of the Revised Statutes of 1923, and repealing said original section.

Be it enacted by the Legislature of the State of Kansas:

SECTION 1. That section 76-401 of the Revised Statutes of 1923 be amended to read as follows: Sec. 76-401. The college for the benefit of agriculture and the mechanic arts, which was located by an act of the legislature of the state of Kansas, entitled "An act to locate and establish a college for the benefit of agriculture and the mechanic arts," approved February 16, 1863, shall be known as the Kansas state college of agriculture and applied science. All properties, moneys, appropriations, rights, privileges and authorities now possessed by the Kansas state agricultural college shall be vested in the Kansas state college of agriculture and applied science

under the supervision and control of the state board of regents as authorized and required under statutes existing at the time of the passage of this act.

SEC. 2. That section 76-401 of the Revised Statutes of 1923 is hereby repealed.

SEC. 3. That this act shall take effect and be in force from and after its publication in the official state paper.

CHAPTER 297.

CHANGING THE NAME OF THE KANSAS STATE TEACHERS COLLEGE OF HAYS TO THE FORT HAYS KANSAS STATE COLLEGE.

House Bill No. 487.

AN ACT changing the name of the Kansas state teachers college of Hays to the Fort Hays Kansas state college, and directing the state board of regents to maintain courses therein, amending section 76-503 of the Revised Statutes for 1923, and repealing said original section.

Be it enacted by the Legislature of the State of Kansas:

SECTION 1. That section 76-503 of the Revised Statutes of Kansas for 1923 be amended to read as follows: Sec. 76-503. The name of the Kansas state teachers college of Hays is hereby changed to the Fort Hays Kansas state college. All properties, moneys, appropriations, rights, privileges and authorities now possessed by the Kansas state teachers college of Hays shall be vested in the said Fort Hays Kansas state college, under the supervision and control of the state board of regents as authorized and required under statutes existing at the time of the passage of this act.

SEC. 2. That section 76-503 of the Revised Statutes of Kansas for 1923 is hereby repealed.

SEC. 3. That this act shall take effect on and after its publication in the official state paper.
