# SciENcv for NSF Common Form Current and Pending Support Generation K-State Office of the Vice President for Research Office of Sponsored Programs Guidance

SciENcv (Science Experts Network Curriculum Vitae) is a tool that is housed within the NIH My NCBI system. SciENcv allows researchers to create a profile, tie it to their Persistent Identifier (NSF will continue to utilize ORCiD: Open Researcher and Contributor ID), and create biographical sketches and current and pending support documents for both NIH and NSF proposals. Other federal agencies may also elect to use this format; refer to your specific funding opportunity announcement (FOA) or funding solicitation for guidance.

# The use of SciENcv to generate Common Form versions of the Current and Pending (Other) Support documents and Biographical Sketches became mandatory for NSF proposals submitted or due on or after May 20, 2024.

### SETTING UP AN ACCOUNT AND DELEGATING ACCESS

- If you do not already have a SciENcv account, you will need to follow a few simple steps to create one.

- Once you have an account, please delegate access to any and all staff persons who work with you on proposals (e.g., Office of Sponsored Programs (OSP) staff, departmental staff, college staff).

#### DELEGATE-INITIATED: CREATING AND EDITING A CURRENT AND PENDING DOCUMENT IN SCIENCV (IF YOU PREFER

#### your delegate/research administration staff generate and maintain the information within your C&P(O)S)

- 1- If you elected to delegate access, research support staff can create a new current and pending document or update an existing document on your behalf.
- 2- Once your research administrator has populated information from K-State's RADAR system in your SciENcv document, they will notify you that it is ready for you to review for accuracy and completeness, update as needed, and certify. Tasks include:
  - a. Add "Identifying Information, Organization and Location" information (blue button on left)
  - b. Remove any pending proposals that have been declined for funding, but please inform staff as well so that RADAR/Cayuse can be updated accordingly.
  - c. Check for errors/typos.
  - d. Review committed time to adjust if needed to reflect your <u>actual, anticipated time</u> spent on each project (including both paid and unpaid effort). If a project has 0 months of charged (budgeted) time, research support staff will enter 0.01 months as a placeholder for your effort on that project. Any projects listed at 0.01 months should be updated to reflect the true person-months of effort spent on the project.
  - e. Add Overall Objectives and Statements of Potential Overlap for each project.
    - Overall Objectives: Provide a brief statement of the overall objectives of the proposal/award. This field is limited to 1500 characters.
    - Statement of Potential Overlap: Provide a description of the potential overlap between each of the projects listed and this proposal in terms of scope, budget, or person-months planned or committed to the project by the individual. If there is no potential overlap, enter "None" in this field. For the current proposal, indicate "This proposal".
  - f. Add any projects on which you spend time for which you do not have formal committed (paid or costshared) effort. If these projects do not appear in Cayuse, you <u>must</u> add the project to the document in

SciENcv. You should include all required information as denoted by the red asterisks.

- g. Add any and all other support that is applicable and required to be reported by NSF.
  - Review the current Disclosures table (<u>https://www.nsf.gov/bfa/dias/policy/disclosures\_table.jsp</u>), which is also included as pages 6-11, and make sure you report any relevant support. Note that support may need to be included in your biosketch or the proposal's Facilities, Equipment, and Other Resources document instead of the Current and Pending document, as indicated within the Disclosures Table.
  - <u>Consulting Activities</u> must be disclosed under the proposals and active projects section of the common form when any of the following scenarios apply:
    - The consulting activity will require you to perform research as part of the consulting activity;
    - The consulting activity does not involve performing research, but is related to your research portfolio and may have the ability to impact funding, alter time or effort commitments, or otherwise impact scientific integrity; or
    - The consulting entity has provided a contract that requires you to conceal or withhold confidential financial or other ties between you and the entity, irrespective of the duration of the engagement.
  - In-Kind Contributions: Disclose ALL in-kind contributions with an estimated dollar value of \$5,000 of ٠ more and that require a commitment of your time<sup>1</sup>. In-kind contributions with an estimated value of less than \$5,000 or without an implied time commitment need not be reported. You should make note to your research support staff of any In-Kind Contributions that are currently included in the document that should be deleted, or, alternatively, delete them yourself. In-Kind Contributions are non-cash contributions provided by a source outside of K-State (both domestic and foreign) that directly support your research and development efforts, including but not limited to: real property, office/laboratory space, equipment, research materials (whether covered by an MTA or not), data or data sets, supplies, goods or services, or employees or students supported by an outside source. It is important to note that In-Kind Contributions intended for use on this project should NOT be listed as Current and Pending Support, but rather included in the Facilities, Equipment, and Other Resources section of the proposal. All other In-Kind Contributions should be listed on the Current and Pending Support form. If the time commitment or dollar value of the in-kind contribution is not readily ascertainable, you must provide reasonable estimates. Please review the NSF FAQs/guidance on In-Kind Contributions (see Disclosure Table and link in Resources section) to help address any questions as to what research activities qualify as In-Kind Contributions.
  - An additional note regarding foreign support: this is an area of emphasis for NSF. Consistent with NSPM-33, the NSF Proposals and Awards Policies and Procedures Guide (PAPPG) requires that you disclose all contracts associated with participation in programs sponsored by foreign governments, instrumentalities, or entities, including foreign government-sponsored talent recruitment programs. Note: Individuals are prohibited from being a party in a malign foreign talent recruitment program. You must ensure that all foreign support is disclosed appropriately. Any other foreign components deemed to not qualify as Current and Pending Support should be disclosed as indicated in the NSF Disclosures Table. Any new foreign support / components should be updated on your Conflict of Interest and Conflict of Commitment filings with the university as well. Also, please note to appropriately mark the Cayuse IPF question in the (PI) Conflict of Interest section regarding foreign support and affiliations.
- 3- Notify your research support staff when you have completed your updates so that they can do a final review.
- 4- Once approved by both you and your research support staff, log in to SciENcv and certify by clicking the download PDF button in the top or bottom right corners. The certification states that the information contained within the document is current, accurate, and complete to the best of your abilities. It also certifies that, at the time of submission, you are not a party in a malign foreign talent recruitment program. This certification displays on the final page of the C&P(O)S.

5- Please notify your research support staff once you have certified the document.

# PI-INITIATED: CREATING AND EDITING A CURRENT AND PENDING DOCUMENT IN SCIENCV (If you prefer to

#### personally generate and maintain the information within your C&P(O)S)

- 2- Communicate with your research support staff to request a current and pending report from K-State's RADAR system. This report will only include activities that have been processed through K-State's OSP as sponsored projects. It should be noted that you may have other sources of support that must be reported to NSF. See Section 8 below for details. Failure to disclose all pertinent information as required by NSF can result in a proposal being declined, an award rescinded, and/or potential civil and criminal penalties.
- 3- Log into your SciENcv account and either create a new NSF current and pending (other) support document or update an existing document to reflect information from the K-State RADAR system. NOTE: If you choose to maintain multiple Current and Pending Documents at a time, it is recommended that you be deliberate with your file naming conventions to avoid risk of working in the wrong document.
  - a. If you are updating an existing C&P(O)S document, please ensure that the "Type" is "NSF Current and Pending (Other) Support (for proposals submitted or due **on or after May 20, 2024**)". If an older version is used, it will not be accepted in Research.gov.
  - b. If you are creating a new C&P(O)S document, whether a blank version or one copied from an existing C&P(O)S, please ensure that the "Type" for the new C&P(O)S is "NSF Current and Pending (Other) Support (for proposals submitted or due on or after May 20, 2024)". If an older version is used, it will not be accepted in Research.gov.
  - c. NSF has adopted ORCiD as the Persistent Identifier for both the C&P(O)S and Biographical Sketch forms.
  - d. Source of support should reflect all sources of funding, including flowthrough if K-State is a subawardee. For example, if OSU receives funding from DOE and subcontracts a portion of work to K-State, this should be reflected in the C&P(O)S as "Oklahoma State University (Flowdown: US Dept of Energy)" or similar language.
  - e. Primary Place of Performance for projects conducted at K-State should reflect "Kansas State University, Manhattan, KS, USA".
    - Projects conducted outside of your capacity at K-State should include City, State, and Country of performance site.
  - f. Person-Months: K-State defines the term "year" as the academic year (i.e. August July). For example, with a project period of Mar 2024 Feb 2025, effort during the time period of March 2024 July 2024 should be reported with the year 2024; effort during the time period of August 2024 February 2025 should be reported with the year 2025, and so forth.
    - For project periods that run for a calendar year (i.e. Jan Dec), all effort should be reported under that single calendar year, due to NSF form limitations. For example: Project period 1/1/2024 – 12/31/2024 would reflect all effort under 2024.
  - g. Overall Objectives: Provide a brief statement of the overall objectives of the proposal/award. This field is limited to 1500 characters.
  - h. Statement of Potential Overlap: Provide a description of the potential overlap between each pending proposal or award and this proposal in terms of scope, budget, or person-months planned or committed to the project by the individual. If there is no potential overlap, enter "N/A" in this field. For the current proposal, indicate "This proposal".
- 4- Add any and all other support that is applicable and required to be reported by NSF.
  - Review the current Disclosures table (<u>https://www.nsf.gov/bfa/dias/policy/disclosures\_table.jsp</u>), which is also included as pages 6-11, and make sure you report any relevant support. Note that support may need to be included in your biosketch or the proposal's Facilities, Equipment, and Other Resources document instead of the Current and Pending document, as indicated within the Disclosures Table.
  - <u>Consulting Activities</u> must be disclosed under the proposals and active projects section of the common form when any of the following scenarios apply:
    - The consulting activity will require you to perform research as part of the consulting activity;
    - o The consulting activity does not involve performing research, but is related to your research

portfolio and may have the ability to impact funding, alter time or effort commitments, or otherwise impact scientific integrity; or

- The consulting entity has provided a contract that requires you to conceal or withhold confidential financial or other ties between you and the entity, irrespective of the duration of the engagement.
- In-Kind Contributions: Disclose ALL in-kind contributions with an estimated dollar value of \$5,000 of more and that require a commitment of your time<sup>2</sup>. In-kind contributions with an estimated value of less than \$5,000 or without an implied time commitment need not be reported. You should make note to your research support staff of any In-Kind Contributions that are currently included in the document that should be deleted, or, alternatively, delete them yourself. In-Kind Contributions are non-cash contributions provided by a source outside of K-State (both domestic and foreign) that directly support your research and development efforts, including but not limited to: real property, office/laboratory space, equipment, research materials (whether covered by an MTA or not), data or data sets, supplies, goods or services, or employees or students supported by an outside source. It is important to note that In-Kind Contributions intended for use on this project should NOT be listed as Current and Pending Support, but rather included in the Facilities, Equipment, and Other Resources section of the proposal. All other In-Kind Contributions should be listed on the Current and Pending Support form. If the time commitment or dollar value of the in-kind contribution is not readily ascertainable, you must provide reasonable estimates. Please review the NSF FAQs/guidance on In-Kind Contributions (see Disclosure Table and link in Resources section) to help address any questions as to what research activities qualify as In-Kind Contributions.
- An additional note regarding foreign support: this is an area of emphasis for NSF. Consistent with NSPM-33, the NSF Proposals and Awards Policies and Procedures Guide (PAPPG) requires that you disclose all contracts associated with participation in programs sponsored by foreign governments, instrumentalities, or entities, including foreign government-sponsored talent recruitment programs. Note: Individuals are prohibited from being a party in a malign foreign talent recruitment program. You must ensure that all foreign support is disclosed appropriately. Any other foreign components deemed to not qualify as Current and Pending Support should be disclosed as indicated in the NSF Disclosures Table. Any new foreign support / components should be updated on your Conflict of Interest and Conflict of Commitment filings with the university as well. Also, please note to appropriately mark the Cayuse IPF question in the (PI) Conflict of Interest section regarding foreign support and affiliations.
- 5- Inform your research administration staff (or email <u>cayuse@ksu.edu</u>) if any pending proposals listed in RADAR have been declined for funding.
- 6- Notify your research support staff when you have completed your updates so that they can do a final review.
- 7- Once approved by both you and your research support staff, log in to SciENcv and certify by clicking the download PDF button in the top or bottom right corners. The certification states that the information contained within the document is current, accurate, and complete to the best of your abilities. It also certifies that, at the time of submission, you are not a party in a malign foreign talent recruitment program. This certification displays on the final page of the C&P(O)S.
- 8- Please notify your research support staff once you have certified the document.

# **POST-SUBMISSION DISCLOSURE: IS IT REQUIRED?**

If, after proposal submission, the researcher and/or the research organization realizes a disclosure was not included in the Current and Pending (Other) Support information, the disclosure MUST be brought to the attention of the sponsor, in some cases within 30 days of discovery. If the status of a project (whether current or pending) changes after the submission of the C&P(O)S, no immediate disclosure is needed; the disclosure will be made upon submission of the next required C&P(O)S (prior to award, at the time of annual report, etc.).

#### **BACKGROUND INFORMATION**

Beginning October 5, 2020, the National Science Foundation required the use of either SciENcv or their fillable PDF form for biosketches and current and pending support documents. The SciENcv and NSF fillable PDF requirements were further updated in the PAPPG released for proposals due on or after October 4, 2021, and then again for proposals due on or after January 30, 2023, with mandatory use of SciENcv (fillable PDFs no longer allowable) beginning in October 2023. The requirements have since been updated with the release of PAPPG 24-1, which became effective for proposals submitted or due on or after May 20, 2024. PAPPG 24-1 requires the use of the Common Forms versions of both the C&P(O)S and Biographical Sketch.

In January 2021, JCORE (the National Science and Technology Council's, NSTC, Joint Committee on the Research Environment) released a document "<u>Recommended Practices For Strengthening The Security And Integrity Of America's</u> <u>S&T Research Enterprise</u>" to offer practical recommendations to research organizations regarding Research Security and Integrity. This document serves as a complementary document to the <u>National Security Presidential Memorandum-33</u> (NSPM-33), which directs Federal departments and agencies to act to protect federally-funded research, including from foreign interference. The January 2021 JCORE document and NSPM-33 implement new guidance requiring research organizations to disclose support and relationships more thoroughly, especially those of a foreign nature. The additional disclosures help maintain the integrity of the research enterprise as a whole, while the transparency shows the appropriate use of public and private funds. Due to both sets of guidance, federal sponsors have increased the level of scrutiny on personnel documents (Biographical Sketches, Current and Pending (Other) Support, and Conflict of Interest) while emphasizing issues with foreign affiliations, overlap, and lack of disclosure.

Part of NSPM-33 guidance was the mandate for standardized disclosure processes, definitions, and forms across funding agencies to the extent practicable. NSF has led the effort, which included generating the Common Forms of Biographical Sketches and Current and Pending (Other) Support, which will go into effect May 20, 2024 for NSF submission. These forms will reduce administrative burden by allowing researchers to use a single base format for all federally-funded applications. NSPM-33 Implementation Guidance has been released by the <u>Council on Governmental</u> <u>Relations</u> (COGR) and <u>JCORE</u>.

From the NSF PAPPG: "It is vital that submission of such disclosure information be taken seriously. The Biographical Sketch and Current and Pending Support documents require the individual to certify that the information provided is accurate, current, and complete. Violation of disclosure requirements may lead to criminal, civil, and/or administrative consequences as may be deemed appropriate based upon the particular facts of the violation. Violations will be thoroughly investigated by the NSF OIG and referred to criminal and/or civil offices within the Department of Justice, when warranted."
